## CIRCULAR

To: All MCA Observers

### **Sub.: Availability as Observer for the season 2016-17**

The 2015-16 Season has come to an end and next season will commence shortly. I thank all the Observers for the cooperation during the last season.

**Following are the instructions issued for noting and for strict compliance.**

1. It has been observed that some of the Observers on the panel of the Association did not officiate in the minimum number of matches during the last season. **It is therefore made mandatory for all the Observers on MCA panel to officiate a minimum 35 match days throughout the season. Those who do not fulfill this condition will not be considered for any benefits from the association which may be applicable from time to time. Habitual offenders are being sent letters separately.**
2. It has also been observed that some of the Observers, after accepting necessary appointments from the Appointing Authority / The Hon. Secretary, Board of Umpires, cancel their appointments at the eleventh hour or they remain absent without prior intimation which causes to a lot of inconvenience which will be viewed seriously and the stern action will be initiated against the concerned Observer including but not limited to removal of the name from the panel of umpire.
3. It has been noticed by the undersigned during the recently concluded Season that many Observers are not well versed with the prevalent Laws of Cricket & Playing Conditions / Model Rules and are not in a position neither to guide the Umpires nor answer any query posed by the captains/ players / team officials during the match. It is therefore earnestly requested to all the Observer to go through the **MCC Laws of Cricket 2000 Code – 6<sup>th</sup> Edition 2015 & Model Rules / playing conditions** before the start of the new season. The erring Observer along with the umpires will attract the disciplinary action deemed fit against him. It is mandatory to attend all workshops conducted by the Association.
4. An observer must have a minimum of 20 years of Umpiring experience in Senior tournaments of MCA or 20 years of Playing experience in Times Shield & Kanga League A division.

**You are requested to intimate your availability in writing for the ensuing season in the enclosed proforma giving complete details latest by 1<sup>st</sup> July 2016. Non receipt of this proforma before the cut-off date shall be considered as your non availability for the forthcoming season.**
