Selected candidates will be called for verification of original documents. However, the corporation reserves the right to conduct any Trial or Test as it may deem fit, depending upon the number of applications received and circumstances.
 - i) The candidate should be regular student of a school or college, except as provided above at Pt. no III A(2)
 - ii) During the period of stipend from FCI he/ she cannot play for any other club or organization without permission from FCI except the School / college in which he/ she is studying
 - iii) He/ She has to represent FCI wherein FCI is participating in the Tournaments.
