Level I Offence

- 1.1. Abuse a cricket equipment or clothing, ground equipment or fixtures and fitting. Showing Dissent at an umpire's decision
- 1.2. Using language that is obscene, offensive or insulting and or making of an obscene gesture, to another player, umpire, observer, team official or spectator. (Language will be interpreted to include gesture)
- 1.3. Excessive appealing, charging or advancing towards umpire in an aggressive manner
- 1.4. Pointing or gesturing towards the pavilion in an aggressive manner by a bowler or other member of the fielding side upon the dismissal of a batsman
- 1.5. Public criticism of inappropriate comment on a match related incident or match official
- 1.6. Any conduct, not covered above, that is contrary to the spirit of the game and/or brings the game into disrepute.

Level II Offence

- 2.1. Repeat of any Level I Offence within 12 months of such nature
- 2.2. Inappropriate and deliberate physical contact between players during the course of play
- 2.3. Deliberate and malicious distraction or obstruction on the field of play (this supplements and does not replace multiday matches and LOM playing conditions clauses 42.2 & 42.3)
- 2.4. Throwing the ball at or near a player, umpire or official in an inappropriate and / or dangerous manner.
- 2.5. Changing the condition of the ball in breach of law 42.3
- 2.6. Any attempt to manipulate a match regard to the result, net run rate, quotient, runs scored or wickets taken or otherwise. The captain of any team guilty of such conduct shall be held responsible.
- 2.7. Intimidation of an Umpire or Observer whether by language
- 2.8. Threat of assault on another player, Team Official, Umpire, Team support staff
- 2.9. Using any language or gesture that offends, insults, humiliates, intimidates, threatens, disparages, or vilifies another person on the basis of that person's race, religion, gender, colour, descent or national or ethnic origin.
- 2.10. Any conduct of a serious nature, not covered above, that is contrary to the spirit of the game and/or brings the game into disrepute.

Level III Offence

- () 3.1. Physical assault of another player, Umpire, Referee, Official, Team support staff
- () 3.2. Any act of Violence on the field of play.
- () 3.3. Using any language or gestures that seriously offends, insults, humiliates, intimidates, threatens, disparages or vilifies another person on the basis of the person's race, religion, gender, colour, descent or national or ethnic origin.
- () 3.4. Any conduct of an overwhelmingly serious nature, not covered above, that is contrary to the spirit of the game and/or brings the game into disrepute
