
The Amicus Curiae has issued a letter dated 25th September 2019 to relax the notice period to conduct the elections as per the advisory of the Committee of Administrators.

ELECTION PROCEDURE

1. The Election process shall be conducted in accordance with the schedule provided below:

2	Last date to submit the names of representatives	Monday, 30 th September 2019 till 3 pm
3	Release of final list of representatives	Monday, 30 th September 2019 at 6 pm
4	Commencement of Filing of Nominations for candidates	Monday, 30 th September 2019 6 pm onwards
5	Last date to file nominations for candidates	Tuesday, 1 st October 2019 till 6 pm
6	Scrutiny of nominations	Wednesday 2 nd October 2019 12 pm to 5 pm
7	Announcement of valid candidates	Wednesday 2 nd October 2019 at 6 pm
8	Withdrawal of nominations	Thursday 3 rd October 2019 till 2 pm
9	Announcement of final list of contesting candidates	Thursday 3 rd October 2019 at 3 pm
10	MCA Elections	Friday 4 th October 2019 8 am to 11 am
11	Results of MCA Elections	Friday, 4 th October 2019 Immediately upon completion of counting which will begin immediately on completion of polling procedure

2. In order for a representative to be considered for inclusion in the electoral roll for the MCA Election, each Ordinary member shall be required to submit an undertaking in prescribed Form A (Annexure – 1) certifying that the nominated representative is an Office Bearer of the Club within the deadlines specified for receipt of such applications in the Election Schedule.

3. Each ordinary member will be required to fill and submit the Specimen Cards of their representative at the MCA Office within the deadlines specified for receipt of applications in the Election Schedule. Specimen cards need not be submitted in case the representative nominated is the same person who has attended the MCA Election held in 2015.
4. All candidates willing to contest the elections will be required to submit an undertaking in prescribed form (Annexure – 2 and 3) within the deadlines specified for receipt of such applications in the Election Schedule.
5. Notwithstanding anything contained elsewhere in these rules, no person who is an employee of the Mumbai Cricket Association (MCA), Board of Control for Cricket in India (BCCI), Indian Premier league (IPL) and Mumbai Indians – IPL franchisee and Garware Club House, either on regular or on contractual basis except any office bearer, Selector, Coach, Umpire and Player elected, appointed or selected by the MCA/BCCI, will be eligible to vote or be elected to the Council or continue as the member of the Apex Council in any capacity.
6. No representatives of a member whose annual subscription and/or other dues is not received on or before 30th September 2019 3.00 pm shall be eligible to vote or be elected to the Apex Council.
7. In case of any dispute or objection as to candidacy, disqualification, eligibility to vote, or the admission or rejection of a vote in the elections to the Apex Council, the Electoral Officer shall decide the same and such decision shall be final and conclusive.

If such a Representative is employed by a Government/Public Sector undertaking under 'Sports Quota', kindly attach a certificate from such Government/Public Sector employer stating that the Representative is employed with such entity under the 'Sports Quota';
- e) The Representative does not hold any office or post in a sports or athletic association or federation apart from cricket;
- f) The Representative has not been charged by a Court of Law for having committed any criminal offence, i.e., no court of law has passed any order framing charges against me;

- g) The Representative has not been an Office Bearer of the MCA for a cumulative period of 9 years;
- h) The Representative is not required to undergo a cooling off period of 3 years in accordance with the MCA Rules and Regulations;
- i) In support of the Ordinary Member's application to have the Representative serve as the official representative of the Ordinary Member for the MCA Election to be held on 04 October 2019 attached herewith are the following additional documents:
1. A self-attested copy of the following Identification and Age Proof document of the Contestant (any one): Passport Voter ID Aadhaar Card
