### **Terms and Conditions:**

1. To deploy 1 Housekeeping Staff in each common washroom (53 Mens & 54 Ladies).
2. Carrying out the Comprehensive Housekeeping Work including all consumables, labours etc. for the various levels of the stadium including all Open area, Garden, Drive way, Toilets and VIP Box Area, Stadium and VIP seats, Foot Over Bridges, D-Road, F-Road, and area outside all Entry / Exit gates.
3. The contractor will maximize the use of mechanical apparatus for the execution of cleaning work. MCA will not provide extension facilities from the available electrical points. Contractor has to submit the list of mechanical apparatus that would be used.
4. Contractor will be responsible for carting away of garbage from the stadium within the time specified by MCA. Contractor shall be responsible for carting away the garbage / leftovers after the post-match bump out of all working agencies from the stadium. The timelines for completion of pre-match & post-match work shall be only be specified by the MCA. Non-compliance will attract penalty as may be laid down by MCA.
5. The payment to the contractor shall be made on the submission of Bill after completion of match.
6. The contractor's employees will have no connection with MCA other than the entrusted cleaning work as per contract.
7. The MCA reserves the right to terminate the contract at any point of time if the contractor does not perform his duties to the satisfaction of MCA. In such case MCA will be entitled to recover additional cost incurred for completion of remaining part of the contract.
8. Water supply & electricity shall be free at stadium from one common point. Necessary supply arrangement shall be in contractor's scope as required.
9. Contractor needs to visit the stadium to see the actual scope of work & importance, before submitting the tender.
10. MCA reserves the right to accept or reject the offer without assigning any reason whatsoever.
