This is further to our correspondence with regards to Mumbai Cricket Association elections. Please find below the extracts from some of the relevant Hon'ble Supreme Court orders for your perusal:

Order dated 5th July 2018 in C.A. No.4235 of 2014:

"As an interim measure, it is directed that as we are going to finalise the draft Constitution, no High Court shall entertain any prayer with regard to appointment of any Administrator hereinafter on the basis of the communication sent by the Committee of Administrators. It is further directed that no election shall be held hereinafter."

Order dated 9th August 2018 in C.A. No.4235 of 2014:

"Upon the registration of the said Constitution of BCCI, each of the members shall undertake registration of their respective Constitutions on similar lines within a period of 30 days thereafter. A compliance certificate must be furnished to the CoA, which shall file a status report before this Court with reference to the compliance undertaken by the State Associations."

Order dated 14th March 2019 in C.A. No.4235 of 2014

"Till Mr. Narasimha, learned Amicus Curiae, submits a report, we consider it desirable that no Court/Tribunal in India shall entertain or proceed with any matter pertaining to BCCI or any State Cricket Association(s) involved."
