Election Procedure

1. Names of Representatives, voter list, specimen cards used for the election of Secretary on 03rd September 2024 shall be held VALID for the election of Councillor on 18th September 2024.
2. If any member club wants to change name of the representative of their club, should submit a duly filled & stamped copy of Annexure – 1 on or before 10th September 2024. The said club should collect new Specimen Card from the office of the Association during submission of Annexure – 1. Duly filled & stamped new specimen voter card should be submitted by the said club on or before 11th September 2024 to the Office of the Association.
3. All candidates willing to contest the elections will be required to submit an undertaking in prescribed form (Annexure 2 and 3) within the deadlines specified in the Election Program for receipt of such applications.
4. Notwithstanding anything contained elsewhere in these rules, no person who is an employee of the Mumbai Cricket Association (MCA), Board of Control for Cricket in India (BCCI), Indian Premier league (IPL) and Mumbai Indians – IPL franchisee and Garware Club House, either on regular or on contractual basis except any office bearer, Selector, Coach, Umpire and Player elected, appointed or selected by the MCA/BCCI, will be eligible to vote or be elected to the Council or continue as the member of the Apex Council in any capacity.
5. No representatives of a member whose annual subscription and/or other dues is not received on or before 7:00 pm on 10th September 2024 shall be eligible to vote or be elected to the Apex Council.
6. In case of any dispute or objection as to candidacy, disqualification, eligibility to vote, or the admission or rejection of a vote in the elections to the Apex Council, the Electoral Officer shall decide the same and such decision shall be final and conclusive.
